Texas Science & Engineering Fair (TXSEF) 2024

Congratulations on your advancement to the Texas Science & Engineering Fair!

<u>The Texas Science & Engineering Fair (TXSEF)</u> 2024 will be in-person at Texas A&M University March 22 - 23, 2024. The competition will follow the guidelines set forth by the <u>Society for Science at the Regeneron</u> <u>International Science and Engineering Fair (ISEF)</u> to determine eligibility. All finalists are required to complete a virtual display board and project overview video within the registration platform. Finalists will also be required to provide a physical display board for the finalist for in person category judging. All displays will undergo Display & Safety inspection. The TXSEF team worked closely with the Scientific Review Committee (SRC) and Display & Safety (D&S) to establish how projects will be judged at 2024 TXSEF.

Read these guidelines thoroughly before registering as an TXSEF Finalist:

- Review the rubric in the guide to better understand how your physical display board will be judged.
- Registration Platforms:
 - STEM Wizard this platform served as the registration platform for Regional Fairs and will additionally be used to facilitate the approval for SRC.
 - Once you have received approval from SRC within STEM Wizard, you will register for TXSEF registration platform called OpenWater
 - > OpenWater -this is the platform finalists will use to register for TXSEF.

Team Projects:

- If students are part of a team project, every team member must register individually in OpenWater.
- Team projects will need to designate one team member as the team lead. The team lead is in charge of submitting all required items (virtual display board/physical display board, project overview video and additional documents as needed).

Required Items:

STEM Wizard

- Once advanced from a Regional Fair, finalists must log in to STEM Wizard, <u>https://txsef.stemwizard.com/</u>. Finalists must complete and upload the <u>TXSEF Abstract</u> <u>Form</u>. This version will be the only version SRC approves for state. Additionally, be sure to update or complete any milestones that are incomplete, and check their Files and Forms to make sure all required paperwork is submitted.
- > SRC
- SRC approval must be completed for your project before you register for TXSEF.
- Finalists will need to login to their STEM Wizard account daily to monitor status and check for SRC messages. When they receive email requests for corrections from the SRC, they need to make these corrections and resubmit within a day of receiving the email
- Approval is indicated by the Files and Forms circle turning green with a check mark, along with all forms being listed as approved.

TXSEF Registration (OpenWater)

- Every finalist must officially register for TXSEF. You will receive an email from TXSEF via STEM Wizard with information on how to register. Finalists will need to login to their STEM Wizard account daily to monitor status and check for messages.
- > Pay all fees to participate in TXSEF. THERE WILL BE NO ONSITE PAYMENT
 - Finalists, teachers, and parents will need to determine who is paying the finalist(s) participation fee.
 - The fee is \$50.00 per student.
 - Personal checks will not be accepted.
 - Any district, school or regional fair paying on behalf of finalist(s) will need to email TXSEF at <u>txsef_registration@tamu.edu</u> and include a full list of all students from the district competing in TXSEF. *Please allow 1-2 business days to receive requested invoices.*
 - Although payment prior to fair is encouraged, we will not require payment up front. *Final deadline to pay is April 30, 2024.*

Submissions

- All submissions must be submitted during registration. <u>Registration is considered</u> incomplete until all required submissions are received.
- > The submission deadline is March 5, 2024, 11:59 p.m. (CST).
- After the submission deadline, projects will then be locked for TXSEF and special award judges to review prior to the fair. Projects that fail to submit revised paperwork in a timely manner will not be eligible for participation in TXSEF 2024.
- > Finalists who advance to TXSEF are required to submit the following when registering:
 - Form 1C (if applicable) PDF format
 - Form 7 (if applicable) PDF format
 - Abstract (PDF format)
 - Note: Your abstract needs to be on the TXSEF Abstract Form with the correct category. This year's Abstract will not have an official state SRC approved seal. Your abstracts will be stamped during TXSEF Display & Safety.
 - Virtual display board (PDF format)
 - Project Overview Video
 - Students can upload a limited number of lab notes, which is optional.
- Compete in-person at Texas A&M University and provide a <u>physical display board</u> (project poster) as well as be interviewed in–person by TXSEF judges.

Requirements

Online Submissions:

1. Virtual Display Board

a. Virtual Display Board (Judges - Review virtual submission)

- Finalists are welcome to make the board look like the one used for the in-person fair, and can use the <u>JR/SR Project BoardTemplate Example</u>. This is an example project board template for students. Finalists may change colors, text box sizes, move panels, etc. *To access this document, you must download and save it to your computer.*
- **P** The template includes additional guidelines.

- Students are not allowed to change the size of the template or add additional pages. Students are allowed three 48" x 36" slides.
- The virtual display board must include the SRC approved Abstract from STEM Wizard as well as Form 1C (Regulated Research Institutional/ Industrial Setting Form) and Form 7 (Continuation/ Research Progression Projects Form), if required for the project. These forms are found on the STEM Wizard Dashboard (left side of screen) and can be downloaded as PDFs. Failure to include these required documents may result in points being deducted during special award judging.
- Many images found on the web are copyrighted. Only use images for which you have the express permission of the photographer/stock image company, and credit the image as required by copyright.

 - Animations or active hyperlinks. Remember: NO hyperlinks!
 - References to an institution or mentor that supported the work or to any patents pending other than what is displayed on Form 1C on slide 4.
 - Personal information such as email address, home address or phone number.
- **The final poster board presentation should be saved as a PDF for submission.**
- All virtual display boards must conform to the same D&S rules as if placed on a physical poster for judges and the public. Passing a <u>Display & Safety</u> inspection will be required to compete.

Avoid these common mistakes on the virtual poster board:

- Student name on the first slide
- Clickable links or hyperlinked URLs
- Adding more pages than allowed
- Pictures of logbook pages
- Only using links to credit sources

2. Presentation - Project Overview Video

a. Project Overview Video (MUST not exceed 2 minutes) – (TXSEF Judges - Review virtual submission)

- Video should summarize the project at a high level and still be understood by a general core audience and should not exceed 2 minutes.
- While judges will have access to this video, it will not be the focus of their project review. Therefore, the video should not include key information omitted in other submitted items.
- If a project is best explained by showing a demonstration, you may include this in the project overview video. This video must meet all <u>Display & Safety</u> regulations.
- Physical poster boards are not necessary in videos because judges will have access to the virtual poster board.
- Only MP4, MPG, MPEG, MOV, and WMV video files are accepted. MP4 or MOV files are recommended.

b. Project Overview Video Tips

The video does not need a physical poster board because judges will have access to virtual poster boards.

Reference the Judging Rubrics for Science and Engineering projects included in this guide to become familiar with how project overview videos will be judged. Additional suggestions include:

Introduce Yourself: State your full name, city, and school. Rather than reciting your project title, consider explaining your project in a single sentence.

- **Explain Your Project by Key Points:** What did you do? What did you find? What conclusions did you draw?
- Any props or visuals used must follow <u>Display & Safety</u> guidelines.
- Only student researchers of the project are allowed in the video. Parents are not allowed!
 Best Practices for Filming:
 - Videos cannot be edited after submission. Keep these best practices in mind to ensure videos are the best representation of the work.
 - Dress appropriately, as if being interviewed by a judge.
 - Film in a well-lit and non-distracting environment so the viewer's focus stays on you and your work.
 - Remove or avoid distractions such as a moving fan in the background.
 - For best results, film horizontally (landscape).
 - Keep the camera still and in place during filming.
 - Speak clearly, loudly, and avoid long pauses.
 - Do **not** increase the speed of the video to stay within 2 minutes.
 - Watch the video before submitting to ensure the lighting is appropriate, the audio is clear, and does not have excessive background noise.

In-person:

1. Physical Display Board: (Judging - In-Person - Live Interviews) March 23, 2024.

Finalists who advance to TXSEF will be required to provide a physical display board (project poster).

- Your SRC Approved Abstract from STEM Wizard will need to be displayed vertically at your booth. If required for the project, Form 1C (*Regulated Research Institutional/ Industrial Setting Form*) and Form 7 (*Continuation/ Research Progression Projects Form*) must also be displayed. These forms can be found in your Files and Forms in STEM Wizard and can be downloaded as PDF's. Failure to include these required documents may result in points being deducted during judging.
- All physical display boards must conform to D&S rules to be displayed for judges and the public.
 Passing a <u>Display & Safety</u> inspection will be required to compete.

2. Presentation

a. Project Presentation: Interview (Judging - In Person - Live Interviews)

- Finalists will be interviewed during initial judging at Texas A&M University.
- Finalists should convey an understanding of their project's basic science, interpretation and limitations of the results and conclusions.
- If a team project, all team members should demonstrate significant contributions and understanding of the project.
- Reference the Judging Rubrics: Science/Engineering located in these guidelines.

Lab Notes (OPTIONAL)

- TXSEF does not require any project to submit a laboratory notebook. However, a finalist may upload a maximum of four individual pages (saved as four separate PDF files; one page = one PDF file) from a lab notebook to provide evidence of its use for online judging of Special Awards.
- Special Award judges reviewing projects online will have access to these optional lab notes, just as they would at a finalists' booth during an in-person fair. However, key information must be provided in the required materials as previously outlined since lab notes are supplemental. A maximum of four pages is allowed in order to protect your intellectual property.
- Lab notes may be provided for in-person judging and must conform to the <u>Display & Safety</u> guidelines.

Judging Criteria for Science Projects

I. Research Question (10 pts)

- clear and focused purpose
- identifies contribution to field of study
- testable using scientific methods

II. Design and Methodology (15 pts)

- well-designed plan and data collection methods
- variables and controls defined, appropriate and complete

III. Execution: Data Collection, Analysis, and Interpretation (20 pts)

- systematic data collection and analysis
- reproducibility of results
- appropriate application of mathematical and statistical methods
- sufficient data collected to support interpretation and conclusions

IV. Creativity (20 pts)

project demonstrates significant creativity in one or more of the above criteria

V. Presentation (35 pts)

a. Poster (10 pts)

- logical organization of material
- clarity of graphics and legends
- supporting documentation displayed

b. Interview (25 pts)

- clear, concise, thoughtful responses to questions
- understanding of basic science relevant to project
- understanding interpretation and limitations of results and conclusions
- degree of independence in conducting project
- recognition of potential impact in science, society and/or economics
- quality of ideas for further research
- for team projects, contributions to and understanding of project by all members

Judging Criteria for Engineering Projects

I. Research Problem (10 pts)

- description of a practical need or problem to be solved
- definition of criteria for proposed solution
- explanation of constraints

II. Design and Methodology (15 pts)

- exploration of alternatives to answer need or problem
- identification of a solution

development of a prototype/model

III. Execution: Construction and Testing (20 pts)

- prototype demonstrates intended design
- prototype has been tested in multiple conditions/trials
- prototype demonstrates engineering skill and completeness

IV. Creativity (20 pts)

project demonstrates significant creativity in one or more of the above criteria

V. Presentation (35 pts)

a. <u>Poster (10 pts)</u>

- logical organization of material
- clarity of graphics and legends
- supporting documentation displayed

b. Interview (25 pts)

- clear, concise, thoughtful responses to questions
- understanding of basic science relevant to project
- understanding interpretation and limitations of results and conclusions
- degree of independence in conducting project
- recognition of potential impact in science, society and/or economics
- quality of ideas for further research
- for team projects, contributions to and understanding of project by all members

Scientific Review Committee (SRC)

The State Science Review Committee (SRC) reviews each project for eligibility. Each project must be cleared by the SRC prior to TXSEF participation. The volunteer-based SRC includes at least one biomedical scientist, one science educator, and one other member. Members of the SRC are knowledgeable about research subject matter and regulations, review required forms for entries, and address any problems before competition. The SRC looks for "red flags" that may require additional forms or project eligibility. The goal of the SRC is to ensure all projects are safe and meet the guidelines set by ISEF. Visit the <u>ISEF Rules Wizard</u> as a first step to help you determine what forms of approvals are necessary.

What are common SRC red flags?

- Human Subjects
 - > If you used human subjects, IRB approval is required.
- Vertebrate Animals
 - > If you used vertebrate animals, SRC approval is required.
- Potentially Hazardous Biological Agents
 - If you worked with microorganisms and/or human or vertebrate animal tissues, cells, or fluids, then SRC approval is required.
 - Certified Laboratories
 - Experimentation involving the culturing of potentially hazardous biological agents, even BSL-1 organisms, is prohibited in a home environment. However, specimens may be collected at home as long as they are immediately

transported to a laboratory with the BSL containment determined by the affiliated fair SRC. For more information about Potentially Hazardous Biological Agents Rules please review <u>ISEF rules</u>.

- The following types of studies involve BSL-1 organisms and are exempt from prior SRC review and require no additional forms:
 - Studies involving baker's yeast and brewer's yeast, except in rDNA studies.
 - Studies involving Lactobacillus, Bacillus thuringiensis, nitrogen-fixing, oil-eating bacteria, and algae-eating bacteria introduced into their natural environment. (Not exempt if cultured in a petri dish environment.)
 - Studies involving water or soil microbes not concentrated in media conducive to their microbial growth.
 - Studies of mold growth on food items if the experiment is terminated at the first evidence of mold.
 - Studies of slime molds and edible mushrooms.
 - Studies involving E. coli k-12 (and other strains of E. coli used solely as a food source for C. elegans) that are performed at school and are not subject to additional rules for recombinant DNA studies or use of antibiotic resistant organisms.
- Checklist and information for SRC Review

Is data collection after the Regional Fair allowed?

Yes. However, finalists cannot add any new procedures involving human subjects, bacteria, vertebrate animals, or anything else that would require approval and was not approved earlier.

Display & Safety (D&S)

Display & Safety inspections include a review of all submitted materials and enforcement of the display guidelines as published in the <u>International Rules and Guidelines</u>. This includes meeting all of the format and size requirements, providing appropriate credits for photographs, graphs and other visuals and having any permissions of individuals depicted in any project materials (on the board or in the project overview video) available.

Judging

Category Judging (Live Interviews) will take place on Saturday, March 23, 2024 at Texas A&M University, <u>Student Recreation Center</u>.

Awards

TXSEF will award first through third place winners in 21 categories in both divisions. There will be a limited number of special awards and scholarships available to select projects. A number of students from the senior division will be selected to attend the <u>Governor's Science and Technology Champions</u> <u>Academy</u> and <u>Thermo Fisher Scientific Junior Innovators Challenge (JIC)</u> finalists will be selected from the junior division. Best in the State for Life Science and Physical Sciences will be awarded to both divisions, plus an honorable mention for each award. Twelve (12) projects will be selected from the senior division to advance to the <u>Regeneron International Science and Engineering Fair (ISEF)</u>. Those selected for ISEF will be required to attend a **mandatory meeting** immediately after the TXSEF awards ceremony.

Step-by-Step Registration Process

The images below are a helpful guide through the registration process. Finalists are able to return and make changes or add submissions before the March 5, 2024, deadline at 11:59 p.m. (CST). Once finalists submit their registration, no additional changes are allowed.

Every finalist must officially register for TXSEF. To register, you will receive an email from TXSEF via STEM Wizard with information on how to register. Finalists will need to login to their STEM Wizard account daily to monitor status and check for messages.

- If you are a new user to OpenWater, you must register by creating an account. Remember to keep track of the email address and password you use for future reference.
- If you participated in TXSEF last year, use your Scienteer email address, select the "forgot password" option, and proceed to generate a new password.
 - If you do not remember your Scienteer email, you will need to create a new account (see first bullet for instructions).

This link should not be distributed to anyone else, as registration submissions will be monitored. Non-state finalists found on the registration platform will be removed.

Once your TXSEF registration has been started, you can revisit and update your submission form in the My Account tab any time before the deadline on **March 5, 2024 at 11:59PM (CST).**

Note: SRC reviews will be completed by March 4, 2024 at 5:00PM (CST).

If students fail to register on time, it will result in automatic disqualification. Please do not wait until the last minute to register your project.

Student researchers, as well as adults who have a role in their projects, are expected to maintain the highest ethical standards. These include, but are not limited to:
 Integrity. Honesty, objectivity, and avoidance of conflicts of interest are expected during every phase of the research. The project should reflect independent research done by the student(s), and represent only one year's work.
 Legality. Compliance with all federal, country, state and local laws is essential. All projects must be approved by a Scientific Revie Committee (SRC), and when necessary must also be approved by an Institutional Review Board (IRB), Institutional Animal Care a Use Committee (IACUC), and/or Institutional Biosafety Committee (IBC).
 Respect for Confidentiality and Intellectual Property. Confidential communications, as well as patents, copyrights, and other forms of intellectual property must be honored. Unpublished data, methods, or results may not be used without permission, and credit m be given to all contributions to research.
 Stewardship of the Environment. It is the responsibility of the researcher(s) and the adults involved to protect the environment an its organisms from harm. All projects involve some amount of risk. Everyone is expected to recognize the hazards, assess the risk minimize them, and prepare for emergencies.
 Animal Care. Proper care and respect must be given to vertebrate animals. The guiding principles for the use of animals in research includes the following "Four R's". Replace, Reduce, Refine, Respect.
Human Participant Protection. The highest priority is the health and well-being of the student researcher(s) and human participant
 Potentially Hazardous Biological Agents (PHBAs). It is the responsibility of the student and adults involved in the project to condu and document a risk assessment and to safely handle and dispose of organisms and materials.

Scientific fraud and misconduct are not condoned at any level of research or competition. Flaglarism, use or presentation of other researchers' work for one's own, and fabrication or falsification of data will not be tolerated. Fraudulent projects will be automatically disgualified.


